

 Trade, and Agriculture



 Increases in frequency of work injuries among workers under 25 and over 55





Frequency of injuries with tenures of <1 year at injury went up





Hypertension And Arthritis Were The Most Common Comorbidities


56% of WC patients had at least one comorbidity at intake



NY Fee Schedule For Professional Services (As % Of State Medicare Rates) Lower Than Most States




NY Prices Paid For Professional Services Were 16% Lower Than Median Study State In 2023

NY Prices Paid For Professional Services Changed Little Since 2020, Following Increases 2018–2020



Prices Paid For Professional Services In NY Grew Less Than Most Other States 2021–2023









How Did Rx Drug Payments Change Between 2015 And 2023?







 Rx payments per medical claim decreased across the study states



How Did The Types Of Medications Dispensed Change Over This Period?




Dermatological Agents Represented Over 30% Of All Rx Payments In NY In 2023Q1


Cost Share Of Rx Payments For Dermatological Agents 2023Q1 vs. 2021Q1


Cost Share Of Rx Payments For Opioids, 2023Q1 vs. 2021Q1




Advanced Practitioners Commonly Provide Care In Many States
